For information purposes and in accordance with the Central Massachusetts Metropolitan Planning Organization (CMMPO) formal Public Outreach Program, the Central Massachusetts Regional Planning Commission (CMRPC) invites decision makers, stakeholders and members of the general public to attend a meeting to discuss proposed Amendment #1 to the CMMPO Endorsed 2015 to 2018 Transportation Improvement Program (TIP). **The meeting will be held on Wednesday, February 4, 2015 at 5:00 PM in CMRPC's conference room, 2nd Floor, Union Station, Washington Square, Worcester.**

The TIP is the listing of all transportation projects - highway, transit, intermodal - in the planning region programmed to receive federal-aid funding. Proposed Amendment #1 calls for the following changes to the highway-related project listing: For Project #607181, Northborough – Marlborough – Interstate Maintenance & Related Work on I-290, add \$3,277,355 to FY 2015 Interstate Maintenance funding, and add \$412,297 to FY 2015 Statewide Stormwater funding.
